 cft whereof is hereby acknowledged, have bargained sold and quit claimed, and  
 by these presents bargained sold and quit him unto the said Emma B. Bishop  
 and to her heirs and assigns forever, all our right, title, estate, interest claim and  
 demand, in possession or expectancy of, in and to the following described land,  
 situated in Lawrence Douglas County, to wit No Four (4) Pineberg  
 Street, according to the survey and plat made by G. D. Searle, T. 1854,  
To have and to hold the above described premises, with the pri-  
 leges and appurtenances thereto belonging, unto the said Emma B. Bishop  
 her heirs and assigns forever. And we the said J. H. Muzzey and F. A. Bailey  
 & Hattie A. his wife for us and our heirs, executors and administrators, do covenant  
 with the said Emma B. Bishop her heirs and assigns, that the said premises are  
 free from all encumbrances made or suffered by us, that we have full right and pow-  
 er to sell, convey and quit claim the same, and that we shall and will warrant  
 and defend the same unto the said Emma B. Bishop her heirs and assigns forever, against  
 the lawfull claims and demands of all persons claiming by through or under us but a-  
 gainst none other. And we the said J. H. Muzzey, and F. A. Bailey and Hattie  
 A. Bailey, our heirs, executors and administrators, are held and firmly bound by these  
 presents, in the sum of five hundred dollars, to the said Emma B. Bishop her  
 heirs and assigns, to make and convey unto her or them all further right or title  
 which shall or may be awarded or conveyed to us by any authority, or by any  
 person or persons whomsoever. In Witness Whereof we have hereunto
