Board discussed Welfare problems with John Derrick, Welfare Director, reviewed policies pertaining to aid to the blind.

It was moved by Mr. Kampschroeder, seconded by Mr. Glass, that the County Engineer be authorized to contract for 15,000 tons of rock to be stockpiled at the Fritzel Quarry, also 15,000 tons at the Walters Quarry. Material to be purchased from Concrete Materials, Inc., at a cost of \$1.20 per ton. Motion carried.

Board received application from Harold S. Reed, 339 Maple, for the position of Civil Defense Director. No action taken.

Board received copy of letter from Clifton C. Calvin, Chairman, Board of Trustees of Lawrence Memorial Hospital, to Ray Wells, Lawrence City Manager. Letter requested city to request that the county consider deeding lots 73, 75, 77, 79, 81, & 83 in Block 21 in West Lawrence, for use as additional space for hospital use. No action taken.
