Extension and total of all bids were checked by Mr. Jack Robinson, Engineer Black & Veatch Engineering Co.. The Engineers estimate was \$31,002.00. It was moved by Mr. Kampschroeder, seconded by Mr. Glass, that the low bid of Wenco, Inc. be accepted, subject to the compliance of the contract requirements of the necessary bonds. Contract awarded for the amount of \$20,490.35. Black & Veatch representative was authorized to issue a work order when all documents are in order. Motion carried. It was moved by Mr. Glass, seconded by Mr. Kampschroeder, that Black & Veatch be authorized to have a resident inspector on the project. Motion carried.
