KAMPSCHROEDER The Board discussed the invitation from the Red Cross to attend a meeting for the purpose of disaster preparedness. It was moved by Mr. Booth and seconded by Mr. Glass that Mr. Kampschroeder be the appointed representative of the Board to attend the Red Cross meeting on February 22, at 7:30 p.m. The motion carried.

The Sheriff appeared before the Board to discuss the problem of breakdown in communication between the City Police and the Sheriffs Department. Since the City Police are operating on a high band radio frequency and the Sheriff's Department is on low band, the Sheriff asked about the possibility of installing receiving sets for three of his cars on the high band. These would be listening units only so his cars would know the whereabouts of the City/Police units. The Sheriff was instructed to submit figures of cost and the Board will consider it at that time.

Superintendent of Public Instruction appeared to ask permission to continue to use the mimeograph machine in his office. Since this machine is not in the same class as a copying machine, permission was granted.

The Clerk of District Court appeared to ask permission to use a small copying machine in her office. Permission was granted as long as fees collected for use of this machine will pay for the supplies and maintenance.

REQUEST Mr. L. T. Merryfield of 1312 West 22nd Terrace, Lawrence, Kansas, appeared before the Board to ask about the possibility of forming a sub-district in Sewer District #10 in Næder Acres. A letter was written to Black and Veatch, Consulting Engineers, asking their recommendations as to the size and location of a sub-district to serve the tract of land in question. Mr. Merryfield was instructed that in order for the County to put a Sewer District into effect, the request would have to be submitted by the owners of at least 51% of the land.

The Business and Professional Women's Organization requested permission to use the Court Room on Tuesday evening, March 19, for a meeting. Request approved subject to availability of the Court Room.

BARN The Board discussed the construction of a barn on Section 26, 13, 19 - five acres in N<sub>2</sub> or NW<sub>4</sub> on old Hadl farm and advised the Zoning Administrator to write a letter to the owner, Mr. Kay, setting forth the regulations that apply advising him of his responsibilities. The Board advised the Zoning Administrator in light of the opinion issued by the County Attorney (6842), the enterprise would not constitute a commercial venture as long as the only activity is one of boarding horses.
