BRIDGE

Mr. Danti Moore appeared before the Board to voice a complaint about the flooding of a low water bridge near his property. The Commissioners directed Mr. L. D. Rice, County Engineer, to send a letter to the Corps of Engineers at the Coast Guard and inquire whether or not they have any plans for this bridge site. Also, Mr. Rice was instructed to extend the concrete pavement on the east and west sides of the bridge to alleviate the problem of washing.

ENUMERATION

The Board received the unofficial enumeration for 1968 from the County Assessor. The Board released the unofficial enumeration to the news media with the following statement: This unofficial enumeration was tabulated from the personal property forms mailed out by the County Assessor and is a very preliminary count. The final count will not be available until July 15, 1968. A complete check of the County is underway to make sure that all residents have reported to the assessor on the forms which were mailed to them around January 1, 1968.

ASSESSMENT

It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the County Assessor be directed to make a current assessment of the land and improvements of the East  $\frac{1}{2}$  of Section 8, Township 14, Range 18, and report back to the Board with the new valuation. Motion carried unanimously.

4-H Remodeling

It was moved by Mr. Kampschroeder and seconded by Mr. Booth that Lawrence Construction Company be authorized to proceed with the remodeling of the existing rest room facilities in the old stone building at the 4-H fairgrounds. Motion carried unanimously.

Intergovernmental

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that Mr. Glass be the County Representative on the Inter-governmental Study Committee. Motion carried.

The Board met with the Welfare Director.
