Commissioners Cancellation Order #560 was approved by the Board and signed by the Chairman. Order is on file with the County Clerk.

EMPLOYMENT AT  
LONE STAR

The Board discussed the hiring of a man for mowing at Lone Star Lake. It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the Board establish a policy of hiring summer employment at Lone Star Lake at the rate of \$325.00 per month based on a 40 hour work week, and incidental help will be paid at \$1.75 per hour.

Purchase vouchers for the month of May were approved by the Board. See proof of publication on file in the office of the County Clerk.

BONDING OF CO.  
OFFICERS

Mr. Edward Moody of Fidelity & Deposit appeared before the Board to discuss the bonding of County Employees. Mr. Moody was instructed to submit a proposal to the County covering the following stipulations: (a) The Clerk of District Court be covered at \$25,000 and the Sheriff be bonded for \$20,000. (b) Each of the elected officers be covered over and above the blanket bond in such a manner that simultaneous losses would be covered.

ENUMERATION

The County Assessor reported to the Board that the Jaycees of Baldwin have been engaged to conduct the door to door enumeration in Baldwin to be completed by June 15 as per instructions given by the Board on May 31, 1968. He further advises that plans are underway to secure a local organization to conduct the same enumeration in North Lawrence. The Assessor also reported that the breakdown between North and South Lawrence in the tentative enumeration figures as reported to the Board on May 29, 1968 are as follows: North Lawrence - 1,988 South Lawrence - 29,245.

PROCESSING

Mr. Barrand of Lesh, Bradley & Barrand appeared before the Board to discuss a feasibility study for transferring the County's tax roles onto data processing systems. Mr. Barrand was instructed to submit a proposal to the Board in writing and it would be considered at that time.

BRIDGE

The Board received a letter from Mr. R. L. Peyton, Acting State Highway Engineer, advising that the State Highway Commission staff has recommended proposed location #1 as submitted by Schlup, Becker & Brennan, Consulting Engineers, for the site of the Kansas River Bridge Crossing in the City of Lawrence, subject to additional traffic assignment work to be completed by the consultant.

No further business, the Board adjourned to meet on June 5, 1968.
