*A-H* The Board met with Bob Bigsby representing the 4-H Fair Board to discuss the installation of a milking parlor at the 4-H Fairgrounds. Approval was given for the construction of such a facility in one of the cattle buildings at the fairgrounds. County to furnish material and skilled labor, 4-H groups to furnish labor.

*SALARY* Judge Rankin appeared before the Board to request a change in salary for clerk, Judith Howey who has now completed five (5) years of service. No action taken.

*LAWRENCE BRIDGE* County engineer, L. D. Rive; Mr. Schlup, and Mr. Horn of Schlup, Becker & Brennan; consulting engineers; Mr. Ray Wells, City Manager, of Lawrence; Mr. George Williams, Lawrence Public Works Director; and Clifford McDonald, Lawrence Chamber of Commerce Representatives, met with the Board to discuss the inspection report of the Lawrence Bridge over the Kaw. This inspection made June 18, 1968, by representatives of the Kansas Highway Commission. No report having been received to date. Lawrence City Manager is to contact the Highway Commission and request a written report as soon as possible.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

*Sec. Bridge* The Board executed an agreement between the Santa Fe Railroad, Jefferson County, The State Highway Commission, and Douglas County pertaining to the construction of the Lecompton Bridge and the work over and adjacent to the Santa Fe Tracks. The agreement was forwarded to Jefferson County for their co-signature.

It was moved by Mr. Kampschroeder and seconded by Mr. Booth that use of the District Court Room by the State Fish and Game Department for the drawing of deer permits on August 8, at 2 p.m. be granted. Motion carried unanimously.

*Comm. Can. ORDER* Commissioners Cancellation Order #567 was approved by the Board and signed by the Chairman.

Douglas County received a Silver Award in recognition of an excellent County Noxious Weed Control Program conducted during 1967.

*SALARY* It was moved by Mr. Kampschroeder and seconded by Mr. Booth that changes in classification brought about by length of service create an automatic advancement in salary to the minimum wage as prescribed in the category to which the employee advances. Motion carried unanimously.

*Request for Road Dedication* Mr. Forrest Jackson, Attorney; Mr. Earl Trowbridge and members of the Willow Springs Township Board appeared before the Board to discuss the dedication and opening of township road in Willow Springs Township. The request for a dedication of a road presently used but not dedicated which is in existence south of Road #62 was received by the Board. It was the unanimous opinion of the Board that any dedication of a new right-of-way would be considered only if it were for a 66 foot right-of-way and if the existing but unopened section of County Road #62 were vacated.
