The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of November 27, 1968.

FAIRGROUNDS

Mr. Harold Holder with Kansas Steel appeared before the Board to discuss a metal building made by Armco for possible construction at the 4-H Fairgrounds. The Board suggested that Mr. Holder discuss the building with Mr. Row, architect for the Board.

LECOMPTON BRIDGE

The Board received authorization from the Kansas State Board of Agriculture for the construction of a temporary causeway across the Kansas River in the area adjacent to the new Lecompton Bridge. Authorization to allow the General Contractor, Frisbie Bridge Company, Inc. to construct the causeway during the construction of the new bridge.

FAIRGROUNDS

Mr. Alvin Row, architect, appeared before the Board with preliminary plans for the proposed building at the 4-H Fairgrounds. Mr. Row was instructed to prepare some cost comparisons for different size buildings and return to the Board for the final decision on plans.

The Board set Monday, December 23, 1968 at 10:00 a.m. as the time to receive bids on trucks for the County Road and Bridge Department.

The Board approved purchase vouchers for the month of November. See proof of publication on file in the office of the County Clerk.

FAIRGROUNDS

It was moved by Mr. Kampschroeder and seconded by Mr. Booth that the County Assessor be authorized to hire door to door enumerators at the rate of \$2.00 per hour or 10¢ per head counted, whichever amount is greater. Also that he be authorized to hire clerical help at the rate of \$260.00 per month and one business assessor at the rate of \$300.00 per month, and further authorized to pay \$2.00 an hour to the township assessors.

Mr. Fred Purvis of Bladwin, Kansas (594-6783) appeared before the Board to discuss the possibility of his becoming the maintenance supervisor for all the County properties. The Board will take the matter under advisement.

The Board approved the time and date of 10:00 a.m., Monday, December 30, 1968 to receive bids for the construction of a 30 foot - 40 foot - 30 foot slab bridge and a double 9 foot concrete box to be constructed on Wakarusa Township Road at bridge #11.0-13.3 and #11.0-13.45.

TAX PROTEST

The Board received a tax protest statement from the Sigma Alpha Epsilon Fraternal Association protesting payment of their personal property tax for the year 1968. Protest was referred to the County Attorney.
