It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the Board accept the letter from Mr. Row dated December 19, 1968 in which he asked to be relieved of his responsibilities as architect for the Douglas County Fair Building and that the Board authorize payment of 50% of the agreed fee of \$2,600.00 for final and complete payment of work completed to date. Motion carried unanimously.

PURCHASE

It was moved by Mr. Booth and seconded by Mr. Kampschroeder that the County Engineer be instructed to place an advertisement for an Assistant County Engineer in the Kansas Governmental Journal, also to send a notice to the University of Kansas and Kansas State University engineering departments advising these departments of Douglas County's needs. Motion carried unanimously.
