The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of December 30, 1968.

Agreement Ambulance
It was moved by Mr. Booth that the Board enter into an agreement with the City of Lawrence for the renewal of agreement for the furnishing of Ambulance service for Douglas County under the same terms and conditions of the agreement for 1968. Motion was seconded by Mr. Kampschroeder and carried unanimously.

Rejection of Bridge Bids
The bids received on December 30 for the construction of a bridge and a concrete box in Wakarusa Township were all rejected and the bid deposits returned to the bidders because all bids were above the engineer's estimate.

It was moved by Mr. Kampschroeder that the date of January 29 at 10:00 a.m. be the time set for the receipt of new bids on the project. Motion was seconded by Mr. Booth and carried unanimously.

The Board received Summons' in Case #25146, Sigma Alpha Epsilon Fraternal Assoc., A corporation and in Case #25147, Alpha Kappa Lambda Building Assoc., A Corporation. These summons' were referred to the County Attorney.

The Board received the quarterly report of Stenographer Fees from the Clerk of the District Court. The report was approved by the Board.

Commissioners Cancellation Orders #612 and #613 were approved by the Board and signed by the Chairmma. Orders are on file in the office of the County Clerk.

The Board approved the advertisement to be placed in the Kansas Governmental Journal and the Kansas Professional Engineering Magazine advertising for an Assistant County Engineer.

Gas Bids
It was moved by Mr. Kampschroeder that the bids for Gasoline and Diesel Fuel for one year for the Road and Bridge Department and Sheriff's Office be received at 10:00 a.m., Monday, January 27, 1969. Motion was seconded by Mr. Booth and carried unanimously.

Typewriter purchase
The Board authorized the Clerk of the District Court to purchase an IBM Model D. Standard typewriter at a total cost of \$495.00 to be taken from the 1968 budget.

The Board met with Robertson and Peters, Architects, to discuss plans for the proposed new Judicial Building.

No further business, the Board adjourned to meet on January 6, 1969.

START TO ACQUIRE PROPERTY
It was moved by Mr. Booth that the Board advise the property owners of the North 12 tracts of land between New Hampshire and Rhode Island lying south of 11th Street that the County will be acting to purchase property and ask their co-operation in permitting the appraisal. The Board will employ a team of property appraisers to make the appraisal and the Board will deal with the owners on the basis of the appraisal plus a 20% factor. The motion was seconded by Mr. Kampschroeder and carried unanimously.

Fairgrounds Bldg.
\$9,900. authorized It was moved by Mr. Booth that the Board authorize the purchase of \$9,900.00 worth of steel for a prefabricated 70 X 80 foot metal building to be erected at the 4-H Fairgrounds by Kansas Steel Built, Inc. of Topeka, Kansas. The motion was seconded by Mr. Kampschroeder and carried unanimously.

The Sheriff was instructed to request bids for 30 cars and also an alternate bid for 6 cars.

The Board discussed ownership of a road in Broken Arrow Park which leads to the Wakarusa Township Fire Station, and the problem of enforcing "No Parking" along this Road. An opinion was requested from the County Attorney regarding these two questions.

No further business, the Board adjourned to meet on January 8, 1969.
