It was moved by Mr. Heck and seconded by Mr. Ice that the Sheriff be authorized to purchase Electronic Siren and speaker system for use on a patrol car. Cost not to exceed \$300.00. Moved unanimously.

The Board received one bid from Copp's Decorating Service for exterior painting on the . No action was taken.

Commissioners Cancellation Order #638 was approved by the Board and signed by the Chairman. on file in the office of the County Clerk.

Mr. Howard Saiger, Executive Secretary of the Air Quality Conservation Commission appeared the Board to discuss the inclusion of Douglas County in a metropolitan (Kansas City) area air control district. The Board will attend a hearing in Kansas City on April 11, 1969 to discuss issue.

The Board received from Mr. Bob Hellstrom, Civil Defense Director, his final proposed plan in the event of a disaster or the threat of disaster. Plan is to be reviewed by the Board.

The Board authorized the purchase of a 12 volt battery for one of the Civil Defense Generators.
