^{PUBLIC HEALTH} The Board received the minutes of the Public Health Committee of the Lawrence-Douglas County Board of Health of April 14, 1969.

^{PRINTING CONTRACT} The Board executed a contract between Melvin E. Copp doing business as Copp's Decorating Service and Douglas County for the painting of the exterior surfaces of the Court House for the total consideration of \$2,968.00.

^{DEED REVISION} The Board executed a revised deed to the State Highway Commission directing an original deed dated September 22, 1938 and recorded in Douglas County Deed Record Book #140, Page 32, under the date of January 12, 1939. Deed covering land presently held by State Highway Commission for a park adjacent to the County owned Black Jack Park on U.S. Highway 56 east of Baldwin, Kansas.

The Board received a letter from Mr. Wes Santee concerning the allocation of deposits of County funds in the Douglas County banks. No action taken.

^{FIRE ESCAPE} The Board received a request for fire escape to be installed on the outside of the Courthouse signed by 23 Douglas County employees. No action taken.

^{TUITION ADJUSTMENT} The Board received notice from the Hutchinson Community College advising of a correction in their fees for the year 1968-69. The enrollment exceeded expectation. Therefore, the tuition will be reduced and the final adjustment will be forthcoming to Douglas County next fall.

^{SKIING AT LONE STAR} It was moved by Mr. Ice and seconded by Mr. Heck that the following regulations pertaining to skiing at Lone Star Lake be adopted for the year 1969.
