The Board received a complaint concerning Musk Thistle on the Baker University Wetlands. Complaint was referred to the Bindweed Department for corrective action.

Investment of \$50,000

The Board instructed the County Treasurer to invest \$50,000 of the Special Building and Equipment fund in 90 day U. S. Treasury Bills through the First National Bank effective this date.

Insurance Release

The Board received and executed a release from the Farm Bureau Mutual Insurance Company, Inc. pertaining to an accident in which a County Bridge was struck by a vehicle owned by Kenneth Tuggle and Alvena Tuggle. Release being in the amount of \$586.57 in payment of all damages and claims on the part of Douglas County. It was moved by Mr. Heck and seconded by Mr. Ice that the release be executed and forwarded to the insurance company. Motion carried unanimously.

Zoning Report

The Board received the first quarterly report from the Douglas County Zoning Administrator of permits issued and fees collected. There was a total of \$285,300 valuation and total fees collected were \$505.50.
