City, Kansas, at the rate of 77.24 per 100 feet delivered to our building site near ... Lawrence, Kansas. Pipe to be used on the Secondary Road Project #FAS 23-S-488(2).

It was moved by Mr. Ice and seconded by Mr. Heck that Resolution #69-13 be adopted ... as of the 27 day of June. Resolution provides for the Douglas County Assessor to ... receive an annual salary of \$8,300 effective July 1, 1969. Resolution shall be ... published by the County Clerk as required by KSA 1968 Supplement 19-424. Motion ... carried unanimously.

Approved the minutes of the meeting of June 27, 1969.

The County Engineer reported to the Board the loss of an approach on Bridge #10.50-1.03 on ... Road #601 in Clinton Township, further identified as the Hallmark Bridge. It was moved ... by Mr. Heck and seconded by Mr. Ice that the Engineer be instructed to remove the damaged ... portion immediately and to proceed with replacement of the approach as soon as possible.

It was moved by Mr. Ice and seconded by Mr. Heck that purchase of carpeting for the ... District Judge's chambers be approved. Carpet to be furnished by the Bud Jennings Carpet ... and Draperies, Inc. Total price to be \$405.00 installed. Motion carried unanimously.

It was moved by Mr. Ice that the engineer be instructed to proceed at once to replace ... the center bent of the wooden bridge from the township road into the Haley property in ... Section 9, Range 19, Township 13. Repairs are to be made to provide a crossing ... equivalent to what was there previous to the flooding. Motion was seconded by Mr. ... Heck and carried unanimously.

Don Palmateer and Bob McIntyre of the Soil Conservation District appeared before the ... Board to submit their proposed budget for the year 1970. No action taken.

The Board received the annual census report as compiled by the Douglas County Assessor ... showing a total county side census of 45,324 persons which constitutes an increase of ... 1,737 within the County over the 1968 census.
