Conditions stated which resipitated a withdrawal of Motion concerning Bond Election for Judicial Blage

of the final enactment of the Congressional tax reform bill of 1969, it is possible that general obligation bonds might no longer be tax exempt, and in such case, this would have a very adverse effect on the interest rates. Final decision on this bill certainly will be forthcoming in the next few months. In light of all these facts, it is deemed advisable that this question not be submitted at least until after the next session of the Kansas Legislature to allow time to examine any changes that will have occurred in the Kansas Statutes, and further to allow time for clarification of the interest rate situation. This delay in submitting the question will have no effect on the continuation of the acquiring of property for the building site. The Board anticipates only a delay in submission of the question until legal ramifications are resolved.

In view of these conditions, it was moved by Mr. Heck and seconded by Mr. Ice that the Board rescind the motion of September 17, 1969, in which it was moved that a bond election be scheduled for the latter part of November or the forepart of December 1969. Motion carried unanimously.

No further business, the Board adjourned to meet on October 3, 1969.

Formula for better funds investment

It was moved by Mr. Heck that to further implement the action of the Commissioners on September 15 in adopting a formula for the deposit of County funds and idle funds investments in the various county banks, the following percentages shall be used beginning January 1, 1970 and continuing through December 31, 1970.

First National Bank	23.64%
Lawrence National Bank	23.21
Douglas County State Bank	19.44
University State Bank	11.77
Kaw Valley State Bank	10.39
Baldwin State Bank	11.55

Each of the banks and the County Treasurer shall receive a copy of the percentage breakdown. Motion was seconded by Mr. Ice and carried unanimously.

It was moved by Mr. Heck and seconded by Mr. Ice that the Clerk of the District Court be allowed to pay her chief deputy on an hourly basis at the rate of \$2.50 per hour for part time work.
