*Water from  
Lone Star Lake  
to Mr. Flory*

The matter of access to stock water from Lone Star Lake as presented to the Board by Mr. John M. Flory on September 17, 1969, was discussed and resolved in this manner. In view of the requirements set out in a deed presented to this Board on September 17, 1969, by Mr. John Flory, and in further view of the County Attorney's Opinion #69-21 on the matter of water rights to Mr. Flory from Lone Star Lake, it was moved by Mr. Heck that the Board grant to Mr. Flory the right to sufficient stock water from Lone Star Lake; this water to be in lieu of water which would have been supplied by the maintenance by Douglas County of a certain designated pond. Motion seconded by Mr. Ice and carried unanimously.

*Resolution 69-13  
Bank depositories*

It was moved by Mr. Ice and seconded by Mr. Heck that the Resolution #69-13 dated October 10, 1969, designating banks to be County depositories, and setting out the various requirements of such banks becoming depositories, be adopted by the Board. Such banks shall be the depositories for all public funds. Motion carried unanimously. See resolution on file.
