The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of November 26, 1969.

*Comm. Order #668 + #669* Commissioners Cancellation Orders #668 and #669 were approved by the Board and signed by the Chairman. Orders are on file in the office of the County Clerk.

Mr. Clifford Nichols, Mr. Ralph Rake, Mr. Raymond Nichols, and Mr. Glenn O'Connor appeared before the Board to discuss the problems on the Stull Road, particularly from Stull West to the County line. The matter was taken under advisement.

Mr. T. H. Olson and Mr. Maynard Beemer, members of the Douglas County Health Board appeared before the Board to discuss the policies and relationships between the public health committee and the Mental Health Committee and the Douglas County Health Board. Discussion covered actions to be taken at the specified quarterly meetings as described in articles of agreement establishing Board.

The Board met with the Welfare Director and Mr. and Mrs. Nice, operators of Valleyview Rest Home.

*salary for town - shop assessors* The Board authorized the County Assessor to pay the Township Assessors \$2.15 per hour for the coming year, motion being made by Mr. Heck and seconded by Mr. Ice and carried unanimously.

No further business, the Board adjourned to meet on December 3, 1969.

The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of December 1, 1969.

*Comm. Order #670* Commissioners Cancellation Order #670 was approved by the Board and signed by the Chairman. Order is on file in the office of the County Clerk.

Bob Neis, Civil Defense Director, Eudora, Kansas, appeared to discuss the installation of the new mobile radio unit for Civil Defense in Eudora. It was agreed that the radio will be installed in the Eudora Firetruck at the present time.

Bob Steele, caretaker at Lone Star Lake, appeared before the Board and reported the removal of the boat dock owned by Masden Pence.

*purchase metal storage shed for Valleyview* It was moved by Mr. Ice and seconded by Mr. Heck that the Building and Maintenance Supervisor be authorized to purchase a 7' x 10' metal building from Montgomery Ward & Company for the amount of \$104.00 and freight. Building to be used at Valleyview Rest Home. Motion carried unanimously.

*purchase light fixtures from Fair* It was moved by Mr. Heck and seconded by Mr. Ice that the Board purchase 25 eight foot Slim Line fluorescent light fixtures for the new fairgrounds building from the Pearson Company in Baldwin for the total amount of \$757.50. Motion carried unanimously.

*Permit granted for a landfill near Baldwin* The matter of request for authority for a sanitary landfill in Eudora, Kansas, was taken under consideration by the Board. The minutes of the Lawrence-Douglas County Planning Commission of October 15, were modified at the request of the Planning Director, Mr. Ron Short, to show the elimination of Recommendation #1. In behalf of the Planning Commission, the requirement for approval by the State Health Department is deleted. It was moved by Mr. Heck and seconded by Mr. Ice that the Board accept the recommendations of the Planning Commission with deletion of this matter. Request is granted subject to the other restrictions. Motion carried unanimously. It was recommended by the Board that a permit be granted by the Zoning Administrator to complete the action and insure permanent record of the approval.

*Notice of appeal in condemnation cases* The Board was advised by receipt of copies of notice of appeal from award in the District Court of Douglas County, Kansas, Case #25533, Board of County Commissioners of the County of Douglas, State of Kansas vs. Anna Laura Tuttle Baker, et. al. Appeals are in behalf of Anna Marian Percival on a tract described as the W 70 feet of Lot #123 on Rhode Island Street in the City of Lawrence, also known as tract 7 in the action; and also an appeal in the behalf of Lurene Michael and Elma Michael on a tract described as the W 75 feet of lot #121 on Rhode Island Street in the City of Lawrence, also known as Tract #5 in the action.

*Engineer to strip one County Road* It was moved by Mr. Ice and seconded by Mr. Heck that the Board authorize the County Engineer to center stripe, as soon as possible, the road known as FAS Rt. 212 from the Kanwaka Corner west to the Shawnee County line. As well as the center stripe, the County Engineer was also instructed to stripe no passing zones and the edge of the roadway. This striping is to be on an experimental basis to determine the advisability of further striping throughout the County. Motion carried unanimously.

No further business, the Board adjourned to meet on December 5, 1969.
