Hearing: Vacation of Kasold Drive

On December 10, 1969, the matter of hearing for petition for vacation of easement from the City of Lawrence for certain real estate in the Northeast Quarter of Section 10, Township 15 South, Range 19 East, and the Northwest Quarter of Section 11, Township 15 South, Range 10 East, said road commonly referred to as Kasold Drive, came before the Board. Due to the fact that proof of publication was not available, the entire Board was not present, and no one appeared in opposition to the petition for vacation of easement, the matter was deferred until December 12, 1969. Motion carried unanimously.

The Board will study the reports and be in contact with the League.
