*County Surveyor's Fee increase*

It was moved by Mr. Heck that the Board approve Resolution #70-1 establishing new rates for the services of the County Surveyor as of January 2, 1970. Motion was seconded by Mr. Glass and carried. See resolution on file in the office of the County Clerk.

*Agreement for Ambulance Service*

It was moved by Mr. Heck and seconded by Mr. Glass that the Board enter into an agreement with the City of Lawrence for ambulance service pursuant to the adoption of Resolution #70-2 this date. Motion carried. See resolution on file in the office of the County Clerk.

It was moved by Mr. Heck that the Board grant authority to the County Engineer to solicit bids for gasoline and diesel for the road and bridge department, and ethyl fuel for the sheriff's department for the coming year. Bids are to be received on the 29th. day of January, 1970, at 10:00 a.m. in the office of the County Engineer, Courthouse. Bid form dated January 5, to be published January 7, and 21. Motion was seconded by Mr. Glass and carried.

*Zoning Reports*

The Board received the quarterly report from John Clyatt, County Zoning Administrator. Report indicated office activities for the last quarter of 1969 and a summary of the years activities. Report showed a substantial increase in residential permits granted during the year 1969, and a total of 162 permits for residential and commercial building showing a valuation increase of \$1,302,380.00.
