The Board of County Commissioners of Douglas County met in regular session with all members of the Board being present.

Approved the minutes of the meeting of March 30, 1970.

Comm Order #728

Commissioners Cancellation Order #728 was approved by the Board and signed by the Chairman. Order is on file in the office of the County Clerk.

Engineering agreement with Finney & Turnipseed for road plans and specs.

It was moved by Mr. Heck that the Board enter into an agreement between Douglas County and Finney & Turnipseed, Engineers of Topeka, Kansas, to provide necessary field surveys, designs, plans and specifications for a road beginning at the intersection of Kasold Drive and Trail Road, thence Northeast and North to near the Northeast corner of Section 27, Township 12, Range 19, Douglas County, Kansas. Total consideration of the services as provided in the agreement is \$9,200.00. Motion was seconded by Mr. Ice and carried unanimously.

Engineering agreement with Finney & Turnipseed for road plans and spec. Sibleyville Road Stoney Point Road

The Board received two proposed agreements from the firm of Finney & Turnipseed, Consulting Engineers. One was for the necessary field surveys, designs, plans and specifications for the improvement of FAS Rt. 208 beginning at U.S. 59 and ending near the Northeast corner of Section 31, Township 13, Range 20, Douglas County, Kansas, more commonly known east from U.S. 59 to its junction with the County Blacktop Road to Baldwin as the extension of Sibleyville Road. Proposed agreement for the services as mentioned is \$6,800.00. The second agreement was for the field surveys, designs, plans and specifications for the improvements of FAS Rt. 1375 beginning at U.S. 59, thence East and South and East to FAS Rt. 210 near the Northeast corner of Section 21, Township 14, Range 20, Douglas County, Kansas. This road is more commonly known as the Stony Point Road from U.S. 59 to its intersection with the County Blacktop Road to Baldwin. Total consideration for the second agreement is \$12,500.00. It was moved by Mr. Ice that the agreement be executed and the engineer is instructed to proceed with the work with a priority to be given to the agreement on the Kasold Road. Motion was seconded by Mr. Heck and carried unanimously.

proposed agreement from engineers, Van Doren, Hazard, Stallings and Schnacke action to accept proposal

The Board received a proposed agreement from the Engineering firm of Van Doren, Hazard, Stallings, and Schnacke from Topeka, Kansas, for the necessary engineering services, surveys, preliminary plans, final design plans and specifications of a proposed road to be located along the South line of Section 12, Township 13, Range 19, and Section 7, Township 13, and Range 30 from U.S. Highway 59 East to point of intersection with Haskell Avenue. The road generally bordering on Broken Arrow Park on the south adjacent to the City limits of the City of Lawrence. It was moved by Mr. Heck and seconded by Mr. Ice that the Board advise the engineering firm that their proposal is satisfactory and to provide the Board with the necessary forms for the entering into of a contract. Motion carried unanimously.

funds authorized to allow Sheriff to send his men to schools.

The Sheriff discussed with the Board the need for Sheriff's personnel to attend different training and information seminars held in conjunction with law enforcement activity and requested an allocation to be expended during the calendar year 1970. Authorization for the establishment of such an item in future budgets for the department was also requested. After discussion, it was moved by Mr. Heck that the Sheriff be authorized to spend not to exceed \$1,000.00 during the year 1970 to send personnel from his department to training seminars and requested the Sheriff to advise the Board each time an employee is going to attend a seminar and the cost of such attendance. Attendance of one deputy to a short course on drug abuse to be held at Southern Methodist University, Dallas, Texas is approved. Motion was seconded by Mr. Ice and carried unanimously.

Zoning report of permits

The Board received and approved the quarterly report of Stenographers Fees for the quarter and March 31, 1970.

The Board received the report for the first quarter 1970 activity of the Douglas County Zoning Administrator, showing new construction permits for residents, mobile homes, and commercial including signs, for a total evaluation of \$264,600.00 and fees collected of \$532.50.

Zoning: proposed changes to the regulations.

The Board received a copy of the minutes of the Lawrence-Douglas County Planning Commission meeting held March 25. Item #11 pertaining to the amendment of Article 19-4(17) of the Douglas County Zoning Regulations was the only portion of the minutes affecting Douglas County. This item was considered by the Board and it was moved by Mr. Heck that any action be deferred pending a joint meeting between the Douglas County Board of County Commissioners and the Lawrence City Commissioners to discuss in detail the proposed ordinance changes. Motion seconded by Mr. Ice and carried unanimously.
