lanning: lotion concerning The County Treasurer called to the attention of the Board nine payments of delinquent personal property tax paid by County residents in which the full amount of tax plus treasurer's interest and fee had been remitted. Since these tax warrants are now technically in the hands of the Sheriff for collection, but since the remittances were made on the basis of a notice sent by the County Treasurer only a few days prior to the notice as sent by the Sheriff, it is evident that there is a great deal of confusion on the part of the tax payer as to which notice they should comply with. After consideration of the checks and the element of confusion brought about by the almost simultaneous sending of notices by the Treasurer and the Sheriff, it was moved by Mr. Heck that the Board instruct the Treasurer to accept these payments, since all cover the full amount of tax, and advise the Sheriff of the cancellation of this warrant. Motion was seconded by Mr. Ice and carried unanimously.
