Civil Defense Surplus (request letter)

Mr. Robert Neis appeared before the Board to request a letter be sent to the State Civil Defense-Surplus Department, authorizing him as Eudora Civil Defense Agent to secure surplus materials.

Reappointment of Co. Planning Com. (Robert Neis)

Mr. Robert Neis also agreed to a re-appointment to serve as a member of the Lawrence-Douglas County Planning Commission for an additional three year term.

Marijuana Indication

Mr. Arthur McDonald and his son, Arthur McDonald, Jr., of 220 North 6th St., Lawrence, Kansas, appeared before the Board to request County Assistance in an effort to eradicate marijuana within Douglas County. Residents of Lawrence approximately 2 years, the McDonalds were advised to contact the Lions Club of Lawrence, who have indicated a previous interest in such a project. Also, the Board assured the McDonalds that every effort would be made to see if County funds could be made available.

Proposed Welfare Budget

The Board met with Mr. John Derrick, Welfare Director, and discussed the proposed 1971 Welfare Department budget. Proposed budget totaling \$1,888,803.56 combined Federal, State and County funds was approved upon motion of Mr. Heck, seconded by Mr. Ice, carried unanimously.
