The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board being present.

Approved the minutes of the meeting of June 17, 1970.

Comm. Order #755 Commissioners Cancellation Order #755 was approved by the Board and signed by the Chairman. Order is on file in the office of the County Clerk.

K.P.E.R.S. In reviewing the personnel employed by Douglas County, it was determined that the present position of Clerk in the County Attorney's office should be a covered position under the K.P.E.R.S. program, therefore it was moved by Mr. Heck and seconded by Mr. Ice that the position will be a covered position and the County Clerk be so advised. Motion carried unanimously.

Order of Dismissal #25646 The Board received a copy of an Order of Dismissal in the matter of Percival versus the Board of County Commissioners in the District Court of Douglas County, Kansas, #25646. The above referred case pertaining to the condemnation of land for the proposed new Judicial Building.

Comm. Order #A-62 The Commissioners received County Commissioners Order #A-62 directed to the Clerk of the District Court, authorizing the cancellation of interest in the amount of \$1.88 on personal property taxes #656 for the year 1966, said warrant having been issued in the name of Mrs. Julius Maurin of Kansas City, Kansas, taxpayer being a non-resident of this County the interest is cancelled. Order was signed by the Chairman and is on file in the office of the County Clerk.

Summer Employment; Vern Sturns Human Relations Mr. Vern Sturns, Human Relations Director for the City of Lawrence, appeared before the Board to discuss the possibility of summer employment for youngsters under the age of 16 in various County offices. Mr. Sturns requested employment consisting of not to exceed two hours per day, five days a week for these youngsters in positions such as clerical or filing or general office work. The Board took the request under advisement to make a determination not later than Wednesday, June 24, 1970.

Time deposit funds Board acknowledged receipt of \$347.50 from the Baldwin State Bank in Baldwin, Kansas, as interest on our time deposit funds on deposit at that bank. The checks were turned over to the County Treasurer for deposit.

Wakarusa Watershed Drainage Ditch Mr. Orman Snyder, Mr. Carter Anderson and Mr. Doug Seibel met with the Board stating that final plans have been completed for the Drainage Ditch to be constructed by the Wakarusa Watershed from Broken Arrow Park south to the Wakarusa River, adjacent to Louisiana Street. The plans will be submitted to the Division of Water Resources for the State of Kansas, for their approval in approximately one month, it is estimated. It is anticipated that after we receive the approval from the Division of Water Resources and about Sept. 1, 1970, invitations to bid on the project will be solicited. Mr. Snyder left a copy of the final plans of the project and copies of the specification details concerning the excess haul on the barrow material. Plans and specifications to be reviewed by the County Engineer and his recommendations given to the Board at a later date. The Board advised Mr. Snyder that we would be in contact with him subsequent to our meeting with our road engineers doing the design work on 31st Street.
