The Board discussed possible revision of policy relating to rights-of-way purchase for road and Highway purposes. After considerable discussion it was moved by Mr. Ice, seconded by Mr. Cragan and carried unanimously that the following policy be adopted: That the consideration to be offered for rights-of-way for Highway purposes may be less than, but shall not exceed 200% of the assessed valuation of the portion of the real estate described. In cases where the acquisition of right-of-way necessitates the relocation of an existing fence, allowance may be less than, but shall not exceed \$4.00 per rod for barbed wire or \$6.00 per rod for woven wire fence. Should acquisition of right-of-way necessitate the building of fence not previously required, the allowance will be negotiated.

The Board discussed with County Counsellor, Dan Young, the procedures of accepting from Mr. Wm. H. Wells an approximate 16 Acre tract of land for the establishing of a park. After due discussion of the advisability of accepting this area and discussing the pertinent reasons for acceptance, such as accessibility, the unique topography of the area and the unblemished natural aspects of the area, it was moved by Mr. Cragan and seconded by Mr. Ice that we adopt Resolution #1-6 accepting this tract of land from Mr. Wells. It was agreed to take the necessary procedure to establish the park under K.S.A. 1970 Supp. 19-2801. Motion carried unanimously. A letter was sent to Mr. Wells advising him of our action and thanking him again for making this tract available.
