County Property Supervisor, Al Skeet, appeared before the Board to present firm bid prices on fixtures required to light the 4-H Judging Arena. The low bid presented by Woods Lumber Co., was in the amount of \$23.00 per unit for 8 ft. 2-bulb fixtures. Voter registra-  
tion*

County Clerk Delbert Mathia appeared before the Board and informed the Board that by action of the 1971 Legislature he, as Chief County Election Official, would henceforth be in charge of voter registration of all of Douglas County effective July 1st. Mr. Mathia also brought to the attention of the Board that the City of Lawrence now has the City's voter registration on a data processing system. Mr. Mathia related that the City of Lawrence computer records would be available to his office, and he would very much like to simply continue with the records which the City of Lawrence now has, and add to the system voter registration of the balance of Douglas County, which would eventually give Douglas County a complete voter registration list on computer. The Board unanimously agreed that Mr. Mathia should follow this procedure.
