County Engineer Rice appeared before the Board to present the Board a proposed notice to contractors which he had prepared. This notice would bring attention to contractors of the intention of Douglas County to construct a roadway on 31st Street, from Louisiana St. to Haskell Ave., to be known as road #699. The notice will request interested parties to bid on this project and will inform interested parties as to manner of procedure in order to place bids on the project. It is proposed that this notice be legally published on July 23rd and August 6, 1971, and a notice will specify that the bids will be opened August 11th, at 10:00 a.m. It was moved by Mr. Cragan, seconded by Mr. Ice that we instruct the County Engineer to proceed with publication of the described notice. Motion carried unanimously.

juveniles*

The Board further discussed a request received recently from the City of Lawrence requesting the County to assume the responsibility for the cost of detained juveniles cared for by the City. After reviewing discussion concerning this matter with the County Counselor, it was moved by Mr. Ice, seconded by Mr. Cragan that beginning July 1, 1971, Douglas County will allow the City of Lawrence the statutory rate of \$2.00 per day for the care of detained juveniles in the City Facilities. Motion carried unanimously.

It was further agreed to advise the City of Lawrence that they should bill for such services monthly, and that said billing should be remitted to the office of the Douglas County Sheriff. It will be expected that the Sheriff's office will review such billing, present same to the Juvenile Court for review and then present to the Commissioners for payment approval.

Twp. census  
figures*

Co. Assessor Darwin Rogers appeared before the Board and presented the Board with a copy of the 1971 Douglas County census enumeration. The enumeration shows Douglas County having 54,420 persons listed in 1971. This figure compares with the 1970 census figure of 57,932 which is a reduction in 1971 of 3,512. However, it should be recorded that the 1970 census was by Federal regulations and that the 1971 census reverts back to regulations as set out by the U.S. Board of Agriculture. The County population is made up of the various City and Township figures as follows:

Board that this road was being brought up to standards including a blacktop surface, that Douglas County would provide a necessary drainage structure through this road.
