The Board indicated that this would appear to be a problem which rightfully should be considered by the Township Board, as Township roads were involved. Later in the morning Mr. Clyde Husted and Mr. Donald Palmateer, representing the Grant Township Board, appeared before the Board to discuss the problem of excessive dust created in part by traffic to the landfill. The Grant Township Board specifically requested a legal opinion on the establishment of speed limits on Township roads, and also in regard to prohibiting the traffic to the landfill on certain roads. The Board agreed to request such an opinion from our Counselor, and to advise the Grant Township Board when such an opinion is received.
