The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Spray equipment for marijuana eradicated by County

Sheriff Johnson reported to the Board that Mr. Arthur McDonald, who has had an interest in controlling the growth of marijuana in Douglas County, but for reasons of health, has given up this venture and wishes to make available to Douglas County the spray equipment and the 2-4 D, which he has on hand. After due discussion it was agreed we would accept this material and equipment, and ask Mr. Bob Steele, Caretaker at Lone Star Lake, to store same at the Lake for use at the Lake, or if occasion should demand we would make the equipment and material available to persons wishing to use same for the express purpose of eradicating marijuana.

To secure bids for painting tower clock

Al Skeet, Property Supervisor, appeared before the Board to discuss painting the Courthouse tower clock. The Board requested Mr. Skeet to secure bids from at least two or three reliable painters for this work, and submit the bids to the Board at his earliest convenience.

Commissioners Cancellation Order #908-2 was approved by the Board and signed by the Chairman. Order is on file in the office of the County Clerk.

Civil Defense Exercise CDEX-71 Nov. 1st to 4th

Civil Defense Director Belote appeared before the Board to report that the Douglas County Defense Organization would be prepared to the fullest extent possible for the annual Civil Defense Exercise known as CDEX-71, which will take place from the time Nov. 1st to 4th of this year. Director Belote indicated he felt this was the proper time to involve as many people as possible to determine how well we are prepared for emergency operation.

Discussion proposed resolution, major street and road plan; further discussion needed

Engineer Sanderson appeared before the Board to discuss a proposed Resolution establishing the major streets and roads plan; providing for the functional classification of major streets and roads; establishing design standards; establishing setback lines on major streets and roads, regulating ingress and egress facilities; providing for appeals to the Board of Zoning Appeals to eliminate hardships; establishing provisions for administration; and providing a penalty for violation. The Resolution also relates to a map delineating the actual road and street plan. Both the Board and Engineer Sanderson indicated the need for further study of the plan and clarification of just what adoption of this Resolution would impose. It was agreed that further discussion would be in order prior to any formal adoption of the Resolution.

No further business, the Board adjourned to meet on Friday, October 15, 1971.

Welfare status report A.D.C. cases; further report to be made

County Atty Mike Elwell, along with John Derrick and Mrs. Friauf of the Welfare Department, appeared before the Board to give the Board a status report of their combined efforts in the matter of A.D.C. cases where husbands have deserted and are not paying child support. Atty Elwell and Mrs. Friauf brought to the attention of the Board that as of this date many fathers have begun paying child support, a good many cases have been closed because A.D.C. recipients have not been willing to follow through on Atty Elwell's requirements, and further there was no way to determine how many cases have not been opened because of strict enforcement of rules and regulations. All parties agreed that lines of communications would remain open on all cases presently being investigated, and further report would be made to this Board.

Comm. Orders 909, 910

Commissioners Cancellation Orders Nos. 909 and 910 were approved by the Board and signed by the Chairman. Orders are on file in the office of the County Clerk.

Douglas Co. Municipal Operation Plan preliminary copies sent

Civil Defense Director Belote appeared before the Board with preliminary copies of the Douglas County Municipal Operation Plan as compiled by the Division of Continued Education of Kansas State University. Director Belote indicated that this material should be reviewed and any corrections or additions made, so that the plan may be published in final form. It was agreed that the Board would review the report with the other governing bodies of the cities of Douglas County to determine what corrections or additions should be made.

C. D. Director Belote to implement CDEX in Douglas Co.

Director Belote also discussed the implementation of the CDEX-71 to be conducted Nov. 1 to 4 nationwide. After due discussion it was moved by Mr. Ice, seconded by Mr. Cragan that we authorize Director Belote to implement the CDEX in Douglas County as determined by him, and with concurrence of the Municipalities of Douglas County. Motion carried unanimously.

Planning Director Short to prepare Resolution for consideration by this Board embodying the requirements which he felt would insure proper sanitation systems in suburban and rural areas of Douglas County.

Ron Short, City-County Planning Director, who recently resigned his position, appeared before the Board with a farewell message. Director Short discussed two areas of action which he felt this Board should act upon very soon. These were the adoption of a proposed Streets and Highways Resolution and the establishment of sanitation requirements conducive to proper development of the suburban areas of the County. As a last duty Director Short was asked to prepare a Resolution for consideration by this Board embodying the requirements which he felt would insure proper sanitation systems in suburban and rural areas of Douglas County. Mr. Short indicated that he would prepare such a Resolution for the Board's consideration.
