investment

banks*

The Board discussed with Treasurer Edythe Norman the possibility of depositing in idle fund investment accounts of our various County banks an additional \$500,000. After due discussion it was moved by Mr. Ice, seconded by Mr. Cragan that as of the date of December 8th, an additional \$500,000 of County funds be deposited in idle fund investment accounts of our various County banks, allocated on the basis of a newly determined 1972 ratio. These funds to be invested in the same manner and drawing interest on the same basis as the present idle fund investments. Motion carried unanimously.
