Engineers Rice and Sanderson appeared before the Board, accompanied by Mr. Joe Roberts, Mr. Tom Craig and Mr. Joe Burton, representing the Corps of Army Engineers. The purpose of the presence of the representatives of the Corps of Army Engineers was to discuss with the Board various items which the Corps of Army Engineers would be involved with the Engineering Dept. of Douglas County, relative to the construction of Clinton Lake. Discussion centered around the relocation of County roads, the responsibilities for construction of certain roads and the standards to which various roads would be constructed. Mr. Roberts of the Corps of Engineers indicated they would like to have periodical visits with the Board so that we may all be kept abreast of developments as pertains to Clinton Lake. The Board expressed a like desire for such communication.
