The Board of County Commissioners of Douglas County met in regular adjourned session with all members of the Board present.

Approved the minutes of the meeting of February 9, 1972.

The Board approved Commissioners Cancellation Order No. 973. Orders are on file in the office of the County Clerk.

Budget Director Darlene Hill appeared before the Board to present the Board statement of fund balances as of December 30, 1971, expenditures and balances of budget appropriations for the period January 1 to December 31, 1971, also comparative statement of 1970 and 1971 expenditures for the 1972 budget. Mrs. Hill indicated that all records for 1971 appeared to be in order.

Zoning Administrator Wayne Kellum appeared before the Board with prepared Resolution #72-9. This resolution relates to the zoning classification change from A-1 to A on the property described as follows: The East 250 feet of the Northeast Quarter (NE_4^2) of Section 12-13-18 in Douglas County, Kansas, generally described as being located two miles south of U. S. #40 and two and one-half miles east of County Road No. 1029. It was moved by Mr. Cragan and seconded by Mr. Ice that Resolution No. 72-9 be hereby adopted and requested that Mr. Kellum see that the resolution is properly published.

Al Skeet, Property Supervisor, presented to the Board bids for a storage cabinet for use in the County Commissioners Office. After due consideration it was moved by Mr. Ice, seconded by Mr. Cragan, and motion carried unanimously, that the bid of Lawrence Typewriter in the amount of \$111.00 less 25% or a net cost of \$83.25 be accepted. The Lawrence Typewriter will furnish one #210 cabinet 64" high by 18" deep by 36" wide.

County Weed Supervisor, Herschel Hemphill, appeared before the Board with quotations re-ceived from five bidders to supply 2,4-D to Douglas County for 1972. The amount to be supplied was 3,500 gal. in various size containers. After reviewing the bids it was moved by Mr. Ice and seconded by Mr. Cragan that the low bid of Baldwin Grain to supply this material at a net delivered cost of \$7,977.00 be accepted. Motion carried unanimously.

darduson't Rice Engineers Sanderson and Rice appeared before the Board to discuss with the Board the bridge inspection report received sometime ago. The report concerns all F.A.S. route bridges which were inspected because of federal requirement and were inspected by contract with the con-sulting engineering firm of Finney and Turnipseed. The report indicated that three bridges were recommended for closing. Two of these bridges being on County Route No. 460 near the Johnson County line and one being on County Route No. 1023 directly on a Douglas-Franklin County line.
