The nursing home study of the Douglas County Comprehensive Health Planning Council appeared before the Board. Those persons appearing were Mrs. Cerf, Mr. Calvin, Mrs. McKinney, Mr. Postma, Mrs. Branson, and Mrs. Lauppe. The purpose of the visit of the committee was to discuss with the Board nursing homes and their operation in Douglas County with specific attention given to Valleyview, since Valleyview is a county home. Specifically the subcommittee is interested in improving nursing home operation in Douglas County and it was generally agreed that the freezing of nursing home rates by the State Department of Social Welfare for welfare patients was probably having an effect on the operation of certain nursing homes. The committee agreed to explore avenues in which they can be helpful in this situation. A request was made by the committee of the Board to investigate the possibility of Valleyview becoming a skilled nursing home. The Board agreed to discuss this possibility with Mr. & Mrs. Nice.

Dr. Ted Kennedy, a citizen interested in pending subdivision regulations, appeared before the Board to discuss the need for, the status of, and possible changes which might be considered in regulations now being presented and studied by the planning commission. Dr. Kennedy's prime concern was that every effort be made to inform the citizens of Douglas County of the content of the regulations being proposed and with this suggestion the Board agreed.

The Clinton Township Board, Mr. Alvin Harrell, Mr. Gene Benander and Pete McNees, appeared before the Board to discuss and to get information relative to the roads which are to be closed in Clinton township relative to the nearing of construction start of Clinton Reservoir. The Board indicated to the Clinton representatives that these closings would be posted as of May 1, and that actual barricading of the closed roads would come only when construction necessitated such. It was agreed during the discussion that the posting of the roads would be carried out by the office of the Douglas County Engineer.
