The date of April 5, 1972, at 9:30 a.m. having been set to consider a petition presented by John W. Dobbins, et al., for admittance of certain lands to Rural Water District No. 2. Said hearing was duly convened with the following as being present for the hearing: Ben Brohammer, Don Stiteler, Ernest Tuckel, John Metsker (Secretary of Rural Water District #2), Donald Churchbaugh (Vice Chairman of Rural Water District #2), Charles Shuck, John Dobbins, and Dan Young. The Board finds that the petition was filed under K.S.A. 82a-622 and that notice has been given as required by law. The Board was presented a communication from Rural Water District No. 2 Board of Directors, showing that a majority of the Rural Water District Board opposed the annexation to the water district of territories described in the aforementioned petition. It was then moved by Mr. Cragan and seconded by Mr. Ice that with this indication of objection by the Board of Directors of Rural Water District No. 2, that the petition filed by John W. Dobbins, et al., for admittance of certain described territories must be denied. Motion carried unanimously.
