The Board noted receipt of a letter from Attorney George Catt, Douglas County Law Day Chairman, indicating that May 1, 1972 will be observed as Law Day USA. Attorney Catt requested this Board to issue a proclamation declaring May 1, 1972, Law Day USA. The Board giving due consideration to the request and following consideration, it was moved by Mr. Ice and seconded by Mr. Cragan that this Board hereby proclaim May 1, 1972 as Law Day USA. The Board further considered bids which were received on April 19 to furnish health insurance to county employees. Two bids were received. The Board agreed that one bid received can not be considered inasmuch as a life insurance section was a mandatory requirement of the bid and such specification did not request this. Following discussion with the firm representatives it was moved by Mr. Cragan and seconded by Mr. Ice and carried unanimously, that the bid proposal of Blue Cross-Blue Shield be accepted to provide county paid health insurance to all full time employees of Douglas County at a cost of \$13.21 per month, with said proposal also providing like dependents coverage by payroll deductions for all employees wishing to purchase such coverage at a cost of \$27.06 per month. Copies of the proposal covering details of the coverage will be on file in the office of the County Commissioners and County Clerk.
