Engineer Sanderson reported to the Board that his department is embarking on an inspection program of all bridges in the county for which the county is responsible. Engineer Sanderson reported that he had employed Mike Jones, a fifth year architectural student, to head a crew of three who will visually inspect and collect all available possible information and data on each individual bridge. This data will be the basis for determining the weight limit to be posted on each bridge and also give Engineering Department updated information needed for a bridge replacement program.

Pauline Woods, Fiscal Officer of the County Welfare Department, appeared before the Board to present and discuss the 1973 Welfare Budget. Mrs. Woods explained that as directed she had prepared the budget according to guide lines as set out by the State Department of Social Welfare. The total budget for 1973 is \$2,530,114.80. Mrs. Woods explained that because of increased county valuation, a sizeable carry-over, and a greater allocation of state and federal funds, that the estimated county mill levy to fund this budget is projected to be 3.317 as compared to 4.852 to fund the 1972 budget. Following due and lengthy discussion of the budget, it was moved by Mr. Ice and seconded by Mr. Cragan that the budget as presented by Mrs. Woods be adopted and forwarded to the State Board of Social Welfare for approval. Motion carried unanimously.

No further business, the Board adjourned to meet on Thursday, June 1, 1972.
