\$1,785.50

The Board noted receipt of a letter from Assistant City Manager of the City of Lawrence with a statement in the amount of \$1,785.50 which represents one-fourth the cost of the new ambulance for lease to Citizens Ambulance Service. The communication explains that although Douglas County had agreed to be responsible for approximately \$1,750 for this ambulance, that the bids came in slightly higher than expected, hence \$35.50 additional cost. It was moved by Mr. Ice and seconded by Mr. Cragan that the Board approve the slight additional cost of the ambulance vehicle. Motion carried unanimously.
