Mr. Paul Caine, representing Douglas County Amateur Baseball Association, appeared at the request of the Board to consider several items relative to possibilities of implementing safety precautions in the area of the baseball diamonds. Due discussion developed agreement that all parking at the baseball diamond would be limited to the area south of the roadway and that gates should be installed so that through vehicular traffic on the road adjacent to the baseball diamond would be restricted during the time the baseball fields were in use. It was agreed that representatives of D.C.A.B.A. would be responsible for the closing and opening of these gates. It was also agreed that D.C.A.B.A. would be responsible for all clean up following use of the baseball diamonds.

Mr. Bob Steele, caretaker of Lone Star Lake, appeared before the Board for a regular discussion relative to various items with respect to the lake area. Following some discussion it was agreed that signs should be installed at lake entrances indicating that only at a designated area was camping or swimming allowed. It was further agreed that at the only area where swimming is allowed, that an appropriate sign should be installed to indicate that swimming is allowed only in a certain enclosed area at each individual's own risk and with proper notification that there will be no life guard on duty. Mr. Steele was instructed by the Board to install the aforementioned signs.

The Board of Commissioners of Franklin County having accepted an invitation of the Douglas County Board to meet for consideration of a mutual bridge problem arrived at the Douglas County Commission office at 11:15 a.m., June 14. Discussion ensued relative to Douglas County Bridge No. 00.00N-01.81E on the Douglas County-Franklin County line and on Douglas County Road No. 1023 or F.A.S. Route 1273. This bridge had been ordered closed as a result of F.A.S. bridge inspections. Present for this discussion were Messrs. Heck, Ice and Cragan, Commissioners of Douglas County; Douglas County Engineer, Mr. Sanderson; and Franklin County Commissioners, Messrs. Yockey, Nichols, and Atchison. It was basically agreed by all present that the condemned bridge should be replaced with a three span 28 ft. roadway bridge with 33'/42'/33' spans. The estimated cost of this structure, including grading, is \$61,000. It was generally agreed that we should consider letting a contract for bridge construction only, with the matter of handling grading in connection therewith to be determined later. Douglas County would remove the old bridge prior to beginning of construction. It was agreed that all costs relative to all items in connection with this bridge construction and grading are to be borne by Franklin and Douglas counties on prorated basis based on 1972 total valuation of each county. The Board of Franklin County Commissioners agreed to advise Douglas County of their decision as to their wishes relative to immediate procedure, within 10 days.

No further business, the Board adjourned to meet on Thursday, June 15, 1972.
