The time of 9:00 a.m. had been established with the joint planning staff and planning commission for the Board to receive recommendations relative to subdivision regulations which had been adopted by the planning commission on July 12. Mr. McClanathan, County-City Planning Director, appeared to present the subdivision regulations recommendations to the Board. Present were: Rees Jackman, Planning Commissioners Mr. Don Haines and Mr. Bill Womack, Zoning Administrator Wayne Kellum, County Engineer Dean Sanderson, and Mrs. Marjorie McKinney. Mr. McClanathan discussed the changes which had been adopted by the joint planning commission following hearings before both the Douglas County Commission and the City of Lawrence Commission. Mr. McClanathan then discussed with the Board the map adopted by the planning commission as part of the recommended subdivision regulations. This map designates the areas referred to as
