Following due discussion with Mr. Wayne Kellum, Zoning Administrator, relative to issuance of these special temporary use permits, it was moved by Mr. Cregan that we issue to Concrete Materials, a division of Martin Marietta Corporation, the requested permits for the Flory and Lothholz guarriss for a two-year period of time beginning September 1, 1972 and ending September 1, 1974, and subject to the following conditions which are hereby made a part of the issuance of these permits.

- Any asphalt plant shall have installed and working a washer or scrubber, or bag house to eliminate all possible dust from the asphalt plant operation, and any asphalt plant shall meet all applicable Federal, State or local operating conditions.
- Roads in the vicinity of the asphalt plant including the haul road from the plant to a public road shall be sealed or oiled to keep the road from becoming a hazard or nuisance.
- Asphalt plant shall be placed as far as possible from any occupied building as long as such location does not interfere with safe operation of asphalt plant and quarry.
- 4. If for any reason the regulations set up for these special temporary use permits are not sufficient to provide conditions favorable to affected property owners, then further steps must be taken to correct such a problem not foreseen at the time of approval of these special temporary use permits.
- 5. The recipient of these permits agrees to ascertain that any asphalt plant operator operating under these permits will have read and agreed to conform to any regulations which have been made a part of these special temporary use permits.
- 6. If a problem arises and no action is taken to correct it within a practical length of time (practical length of time shall be determined by the County Zoning Administrator, the Board of County Commissioners, and a representative of the special temporary use permit holder), the permit holder will be notified by the County Zoning Administrator to stop operation of the plant until the problem is corrected.
- 7. Any extension of time of these special temporary use permits must be by approval of the Board of County Commissioners.
- 8. Proof of valid lease to permit holder for these quarry sites must be on file in the office of the Zoning Administrator and the special temporary use permits shall become void should such lease cease to be in effect.

The motion was seconded by Mr. Ice and carried unanimously.
