Darlene Hill, Budget Director, appeared before the Board with finalized 1973 budget figures. The Board having held numerous discussions with Mrs. Hill relative to the 1973 budget, it was noted that the final presentation was in line with these previous discussions. The 1973 budget will require a levy of 26.61 mills. The 1973 budget requires funding in the amount of \$5,504,485.
