Mr. Darrell D. Hammond, representing the consulting firm of Van Doren-Hazard-Stallings-Schnacke, and Engineer Sanderson appeared before the Board with bids on Phase II, 31st Street from U.S. 59 to Haskell Avenue referring to that section from Louisiana Street to Highway 59. Four bids were received, those being from the Hankamer Asphalt Co., Topeka; M. W. Watson, Inc., Topeka; May-Ransom-Sheetz, Contractor, Inc., Topeka; and W. R. Hamm Contractor, Inc., Perry. The engineer's estimate on the cost of the project was \$201,346.55. The apparent low bidder for the project was W. R. Hamm Contractor, Inc., with a bid of \$187,609.17. The Board agreed to take final action following computation of all bid items by consulting engineer.

The Board adjourned the regular meeting at 10:45 a.m. in order to appear before the subcommittee of the Governor's Committee on Criminal Administration. The appearance before the committee is to present to the committee the need for requested funds for the renovation of and equipping of the second district court facility for Douglas County.

No further business, the Board adjourned to meet on Thursday, July 27, 1972.

July 27, 1972

The Board of County Commissioners of Douglas County met in regular adjourned session with two members of the Board being present. Mr. Cragan was absent.

Approved the minutes of the meeting of July 26, 1972.

John Derrick, Welfare Director, appeared before the Board along with Al Skeet, Property Supervisor, to further discuss with the Board the implementation as of August 1, 1972, the Douglas County Welfare Work Program. It was generally agreed that this program would be started with the available workers being assigned to duties at the Fairgrounds and at Lone Star Lake. Mr. Skeet will have the responsibility of signing in and directing the workers each morning. Mr. Derrick presented the Board agreements to be implemented between the Douglas County Board of Social Welfare and the State Department of Social Welfare relative to the operation of the welfare work program. The Board attached signatures to these agreements. The Board agreed that workmen's compensation relative to the welfare work program would be paid from the county general fund.

Mr. Travis Glass, Chairman of the Solid Waste Committee, and Mr. Dave Blackman, Coordinator of the Solid Waste Program, appeared before the Board to discuss proposals and recommendations of the committee. Mr. Blackman indicated that he is visiting with the state board relative to these proposals and recommendations and that it is his hope to gain concurrence by all who must approve their recommendation prior to final publication. Mr. Fred Purvis, representing the Baldwin City Council, appeared before the Board to express the sentiments of the Baldwin City Council that it would be their preference to continue their own collection service. The discussion that followed after reading the recommendations of the solid waste committee would indicate sufficient latitude to allow any municipality to assume the responsibility referred to by Mr. Purvis.

Engineer Sanderson brought to the Board information that recomputation of the figures relative to the bid of N. R. Hamm Contractor, Inc. for Phase II, 31st Street project indicated no discrepancies. It was moved by Mr. Ice and seconded by Mr. Heck that we officially award the contract for that project to N. R. Hamm Contractor, Inc. at the bid figure of \$187,609.17. Motion carried unanimously.

No further business, the Board adjourned to meet on Monday, July 31, 1972.
