Following due presentation of all facts in the case, Counselor Young advised the Board that since the Richardson's acted on reliance on the court order that even though said order may not have been in proper form, the county received the benefits of the Richardson's services as foster parents for a juvenile resident of Douglas County and that the Richardson's would seem to be entitled therefore to recover the claim against the county. It was then moved by Mr. Ice that the claim of Mr. and Mrs. Raymond Richardson be allowed, seconded by Mr. Cragan, and carried unanimously.
