Engineer Sanderson accompanied by Messrs. Joe Burton, Schauf, Joe Roberts, and Tom Craig, of the Right-of-Way Division of the U. S. Army Corps of Engineers, appeared before the Board to further discuss the standards to which the Corps will construct relocated Roads 1 and 2, otherwise known as the circumference roads around Clinton Lake. Agreement was reached on the standards which basically will equal those standards of which county improved secondary highways have been constructed in Douglas County in recent years. The representatives of the Corps of Engineers will draft contracts reflecting the standards and specifications for review and adoption by the Board in the near future.
