Approved the minutes of the meeting of October 26, 1972. The Board approved Commissioners Cancellation Order No. 1025. Order is on file in the office of the County Clerk. Assessor Darwin Rogers presented to the Board a proposal from M & M Office Supply to supply a No. 6329 all steel typewriter desk at a cost of \$251 de-livered and installed. Mr. Rogers explained to the Board that this desk would be compatible with present equipment in his office and felt that the price was a competitive price. With this information it was moved by Mr. Cragan that this proposal be accepted, seconded by Mr. Ice, and carried unanimously. Property Supervisor Al Skeet appeared before the Board to explain to the Board

the work load brought about by the upcoming election which necessitated a part time temporary employee for this purpose. Mr. Skeet requested approval for employment on a temporary basis of Mr. Charles K. Newman at a wage rate of \$2.25 per hour effective October 30, 1972.
