Report*

The Board noted receipt from District Judge Frank Gray and County Attorney Mike Elwell of a jail inspection report setting out the condition of the Douglas County jail as of October 31, 1972. The report indicates that with due allowance for age the jail is sufficient for the safekeeping of the prisoners and the accommodations and health of prisoners. The report indicates the need of some minor repairs. The final statement of the report recites that with due allowance for the age of the facilities, the jail appears to be as efficient as such facilities will permit.

The Board noted receipt of a telegram from the office of U. S. Senator James B. Pearson directed to Civil Defense Director Belote to the effect that his office had been informed by the Department of Defense that a grant in the amount of \$32,211.75 had been awarded to Douglas County. This grant provides funds for the procurement and installation of fifteen warning sirens in the cities within Douglas County. The State Office of Civil Defense has confirmed the approval of this grant request.
