Planning Director McClanathan and Zoning Administrator Kellum appeared before the Board to discuss planning items which come to the Board from the Planning Commission relative to the Planning Commission meeting of November 29, 1972. The first item presented by Mr. McClanathan was that of the final plat of Sandyland Subdivision. This is a plat of 8.09 acres generally located approximately 1/4 mile north of Grant Township Road No. 23 on the east side of U. S. Highway No. 24-59. This final plat was approved by the Planning Commission and the commission recommends that this Board accept the dedications relative to the final plat. With the information the Douglas County Engineering Department had indicated approval of the dedications, it was moved by Mr. Ice that this Board accept these dedications, seconded by Mr. Cragan, and carried unanimously.

Mr. McClanathan then presented Item No. 6 of the minutes of the November 29 Planning Commission meeting which item refers to a request to rezone 15.08 acres from A to R-1. This property is located on the southeast corner of the intersection of Kanwaka Township Roads No. 7 and 46. This item was referred from this Board to the Planning Commission with a request for reconsideration. The Planning Commission recommends denial of this request for rezoning. Following due discussion it was moved by Mr. Ice that we accept the recommendation of the Planning Commission which is for denial of this request for rezoning for the reasons that:
