Dr. Larry Mayer, Dr. Gary Condra and Harold Hutton appeared before the Board to discuss with the Board a grant request application which has been prepared by Boys Club of Lawrence and Volunteers in Court to be submitted to the Governor's Committee on Criminal Administration. The request will be for a total amount of \$60,893 of which \$15,339 would be subgrantee contribution with a request from G.C.C.A. of funds in the amount of \$45,554. The program basically would provide funds through which the Boys Club would work in the area of delinquency prevention and the Volunteers in Court would work primarily in the area of rehabilitation. Following considerable discussion it was moved by Mr. Cragan that we approve and enthusiastically support the submitting of this grant request to the G.C.C.A., seconded by Mr. Ice, and carried unanimously.

Treasurer Edythe Norman appeared before the Board to request several length of service increases and one reclassification for employees in her office.
