Dr. Forrest Brown along with the representative of the Thomas Shows appeared before the Board to discuss reserving the Douglas County 4-H Fairgrounds to present said shows during the period April 11 thru 21. Dr. Forrest Brown represented the Abdallah Shrine Temple, which organization will be the sponsor of this presentation. Dr. Brown informed the Board that the Abdallah Temple will assume the responsibility for supervision of all activities on the fairgrounds pertaining to this venture. Following considerable deliberation the Board agreed that even though it was recognized that this request was for an unusual length of time that the request would be granted. It was further agreed by the Board that any future such length of reservations might well be related to the results of this particular action. It is understood by all parties concerned, that no trucks are to use any black-top road or parking other than the road marked "Truck Entrance". It is further understood that any damage to black-top surface shall be repaired in the manner satisfactory to the Board of Douglas County Commissioners even though said repair should exceed the amount of the original \$500 deposit.
