The Board noted receipt of communication from the City of Lawrence setting out two revisions in proposed stipulation relative to Douglas County assuming responsibility for providing county-wide ambulance service. It was moved by Mr. Stoneback that the City of Lawrence be advised that the revisions of the county's proposal are accepted, seconded by Mr. Heck, and carried unanimously. The Board then considered finalizing of contract to purchase all ambulance equipment presently owned and used by Mr. Larry Marcum in operation of Citizens Ambulance Service. It was moved by Mr. Heck that we approve purchase of this equipment as per schedule which is a part of signed Bill of Sale for the sum of \$8,000 and this purchase be made by the use of county revenue sharing funds with the actual transaction being consummated on March 26, 1973, seconded by Mr. Stoneback, and carried unanimously.

mote radio

Mr. Charles Denniston, Administrator of Lawrence Memorial Hospital, was contacted by Commissioner Arthur Heck relative to the possibility of the hospital installing a remote radio control unit compatible with the ambulance service. Mr. Denniston advised the Board that the hospital would make such installation as soon as same can be accomplished. This installation will allow the ambulance driver to communicate with the hospital at all times.

It should be noted in addition to all present State required standards for ambulance drivers and attendants, the county will require a minimum of 40 hours emergency training as now offered by KU Medical Center and an additional 40 hours of training will be required if such additional training is available in Douglas County.
