Mr. Jerry McKenney, representing Dictograph Security Systems, presented as requested a proposal for the installation of smoke and heat detector system in Valleyview Care Home. Inasmuch as smoke detection had been purchased but not installed, and we now find that new legislation dictates that a smoke detection system only is not sufficient, it was agreed to return the smoke detectors and receive credit for same less handling expense. It was then moved by Mr. Heck that the Board accept the proposal of the Dictograph Security Systems for the installation of a complete smoke and heat sensor system at Valleyview Care Home as described in the contract for the sum of \$2710, and that this payment be made from revenue sharing funds under the revenue sharing guidelines "Capital Improvements". Motion was seconded by Mr. Cragan and carried unanimously.

No further business, the Board adjourned to meet on Wednesday, June 20, 1973.
